#### **Materials and Techniques for Direct Restorations**

Although posterior composites may seem trivial, there are many clinical factors which lead to a long-lasting restoration, including diagnosis, isolation, caries removal, cavity preparation, use of liner, matrix and wedge placement, bonding technique, composite placement, and finishing and polishing. This course aims to review the techniques for each of these steps based on current evidence.

# **Pharmacology Full-Day Lecture**

Professor Karen Baker has been on the Dental College faculty at the *University of Iowa* for over 40 years and occupies a unique role in dental practice and education. She is a clinical pharmacist with a Master's degree in clinical pharmacology and therapeutics and is focused on patient specific dental drug therapy. She has given well over 1000 invited programs nationally and internationally and holds memberships in many dental and clinical pharmacology and therapeutics organizations. Her dental education-based pharmacy and drug therapy consultation center is the only one in the United States. She has authored many articles and abstracts and lectures extensively in pre-doctoral and graduate courses at the University of Iowa.

#### **Advances in Dental Pharmacotherapy:** How to Maximize Success While Limiting Risk in Everyday Practice

Antibiotic stewardship has taken on new importance with the emergence of superbugs and the decline in effective and available oral antibiotics. This program will update the dental team on recent developments in dental antibiotic prescribing and outline strategies for prescribing to ensure therapeutic success with minimum risk. Difficult questions about antibiotic prophylaxis and all relevant guidelines and decision tools will be included. Opioid prescribing remains controversial, especially in young, opioid naïve patients. We will explore alternatives and strategies that benefit patients and reflect positively on your practice.

- Select regimens for odontogenic infections based on allergies, intolerances, effectiveness, Black Box Warnings, and guidelines
- · Prescribe antibiotic premedication for certain patients with a variety of implants including cardiac and orthopedic devices, and
- · Discuss the pros and cons of prophylactic antibiotics for implant placement, tooth extractions, and other surgical procedures
- Discuss the extent of the opioid substance use disorder problem in the U.S. and examine the role of dental opioid prescribing in contributing to the opioid epidemic
- Explain the relative effectiveness of non-opioid and opioid agents in acute pain
- · Discuss benefits vs risks of specific pain control regimens for effective dental analgesia
- · List the top five drug interactions every dental clinician should know about

#### Hot Therapeutic Topics for the Dental Team: From Weed to Weight Loss!

Substance Use Disorders (SUDs) are unfortunately both common and destructive in our society. We will discuss new developments in the neurophysiology and treatment of common SUDs. Recreational marijuana is currently legal in 24 states and initiatives are currently being promoted in many more states. We will review the pharmacology of cannabis products and discuss oral effects and dental treatment ramifications for patients who frequently use cannabinoids with special emphasis on risks of high potency THC among adolescents.

- Discuss the neurophysiology, neurotransmitter & mental health disorder basis for SUDs
- List the dental pain management and anesthesia implications of chronic cannabis use
- · Identify the signs and symptoms & treatment alternatives for alcoholism and other SUDs
- Update office protocols for treating patients with high blood pressure readings
